T2.2 Interviewing users of services of selected urban areas

Interviews are one of the six activity tasks in Work Package 2 whose main result is the development of a digital toolkit for SAFE Accessibility to help make communities more accessible and inclusive. As all the activities in Work Package 2 also interviews have a multidisciplinary approach to raise awareness of the issues faced by people belonging to vulnerable groups and to develop a toolkit to tackle these issues. Impact and target groups are students, teachers, residents, visitors, business managers and employees, associate partners, and public authorities responsible for urban areas. Interviews are developed by partners and tested in different activities and studies during the project by stakeholder representatives and students. Based on testing, the results provide information on how useful the interviews and the whole toolkit is. With the help of the interviews all project target groups, including vulnerable people, locals, and visitors, can benefit from greater awareness and knowledge of the primary issues in terms of accessibility and safety. Also, Managers, employees, and public authorities can benefit, because it helps them self-assess their position on the accessibility and safety they offer to vulnerable groups. Interviewing users of services in selected urban areas with a focus on the analysis of the open spaces helps to understand and research the movement of people, especially related to issues of accessibility, safety, and inclusion. With qualitative interviews in the local communities, many impacts can be measured. They can also offer a deeper understanding of the behavior and needs of users of services, especially diverse specific target groups which ensures that the gained insight will be transferable. With the help of interviews, one can critically understand the meaning of the functionality of urban areas and spaces.

SAFE team, in all countries, interviewed users of services of selected urban areas with the focus on analysis of the open spaces. Data from interviews conducted with customer target groups are share in open access repository Zenodo.
