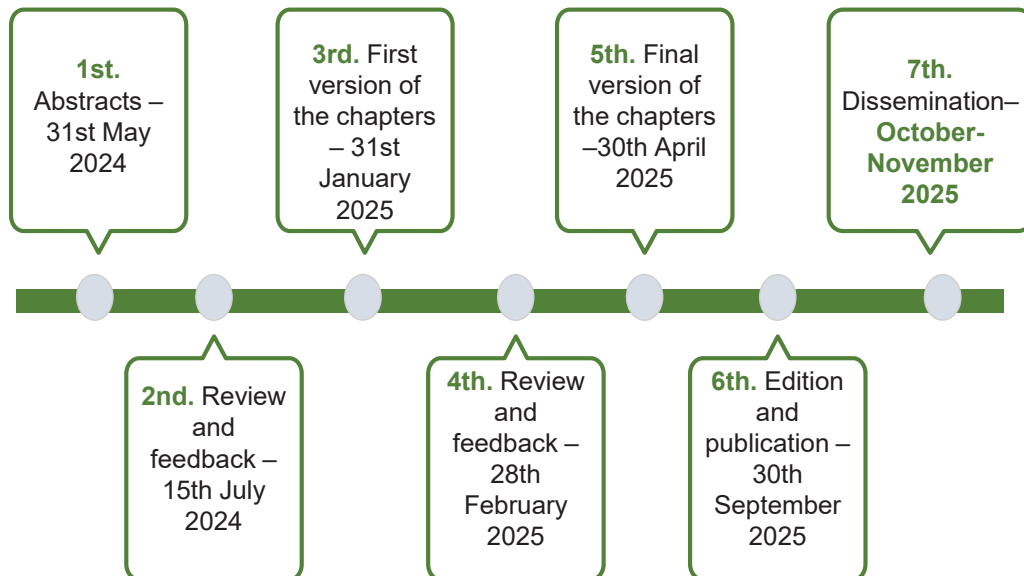

Planning and stages



- 1ST STEP:** Delivery of a structured abstract of the chapter (using the template).
- All the members - 31st May 2024. (Send to apolo@ugr.es, fpeco@ugr.es).**
- 2ND STEP:** General review of the coherence of the book considering the content discussed in the abstracts.
- Identification and assignment of authors if there are chapters without authors.
- Feedback to the authors in relation to the contents discussed (from the point of view of giving coherence to the book).
- UGR and WSG teams. 15th July 2024.**
- 3RD STEP:** Delivery of the first version of the chapters.
- We suggest that if the chapter includes recommendations or implications for vulnerable collectives, it should include the review or suggestions from the professional associations or institutions. This revision should be done by every responsible-author team.
- All the members - 31st January 2025 (Sent to apolo@ugr.es, fpeco@ugr.es).**

- 4TH STEP:** Review of the chapters: general review about the coherence along the handbook, the English style,...
- Feedback to the authors.
- UGR and WSG Teams – 28th February 2025.**
- 5TH STEP:** Delivery of the final version of the chapters.
- All the members – 30th April 2025 (sent to apolo@ugr.es, fpeco@ugr.es).**
- 6TH STEP:** Editing process (we are going to try to include accessibility tools).
- Edition process with ISBN and in open access license.
- Prologues (They could be written by or with the Professional local partners)
- UGR and WSG Teams – 30th September 2025.**
- 7TH STEP:** Dissemination and divulgation.
- All the members – October to November 2025.**
